Opinion

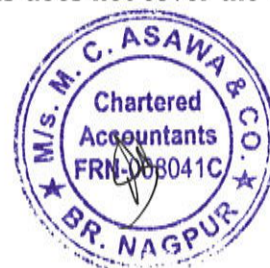

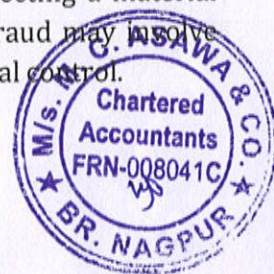
Those Board of Directors is also responsible for overseeing the company's financial reporting process.

Report on Other Legal and Regulatory Requirements

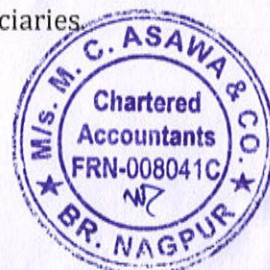

Use of estimates The preparation of financial statements, in conformity with the generally accepted accounting principles, requires estimates and assumptions to be made that affect the reported amount of assets and liabilities and disclosure of contingent liabilities on the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Differences between actual results and estimates are recognized in the period in which the results are known / materialize.
d.	Inflations Assets and Liabilities are recorded at historical cost to the company. These costs are not adjusted to reflect the changing value of purchasing power of money
e.	Revenue recognition Revenue is recorded net of trade discounts, rebates and includes excise duty. Revenue from sales of products is recognised when the significant risks and rewards of ownership of the goods have passed to the buyer. Income from services is recognised as they are rendered based on agreements/arrangements with the concerned parties Dividend income is recognised when the right to receive is established. Interest Income is recognised on time proportion basis taking into account the amount outstanding and rate applicable.

g. Inventory	There are no inventories at the end of the financial year.
h. Earning Per Share	Basic earnings per share are calculated by dividing the net profits for the year attributable to equity shareholders by the average number of equity shares outstanding during the period. Earnings considered in ascertaining the Company's earning per share is the net profit for the period after deducting income tax. For the purpose of calculating the diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the average number of shares outstanding during the period is adjusted for the effects of all dilutive potential equity shares.
i. Taxes on income	Tax expense comprises of current tax and deferred tax. Current tax is measured at the amount expected to be paid to/ recovered from the tax authorities, using the applicable tax rates. Deferred income tax reflect the current year timing differences between taxable income and accounting income for the year and reversal of timing differences of earlier years / period. Deferred tax assets are recognized only to the extent that there is reasonable certainty that sufficient future income will be available except that deferred tax assets, in case there are unabsorbed depreciation and losses, are recognized if there is virtual certainty that sufficient future taxable income will be available to realize the same.
j. Employees Benefits/Retirement Benefits	Short Term employee benefits are charged off in the year in which the related services are rendered. Contribution to Provident Fund is charged to Profit and Loss Account as incurred.
k. Leases	Lease arrangements where the risks and rewards incidental to ownership of an asset substantially vest with the lessor are recognised as operating leases. Lease rentals under operating leases are recognised in the Statement of Profit and Loss on a straight-line basis over the lease term.
